BOOTS TO BUSINESS (B2B) TO OFFER TRAINING TO TRI-STATE VETERANS

Boots to Business (B2B) is an entrepreneurial education and training program offered by the U.S. Small Business Administration SBA as part of the Department of Defense transition assistance program (TAP).

The course provides an overview of entrepreneurship and applicable business ownership fundamentals. Active-Duty service members (including National Guard and Reserve), Veterans of all eras and spouses are eligible to participate.

The “Introduction to Entrepreneurship” course is a foundational piece of the Boots to Business (B2B). Participants are introduced to skills, knowledge, and resources needed to launch a business. This is a one-day program, facilitated by subject matter experts from the SBA and their extensive network of skilled business advisors.

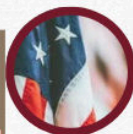

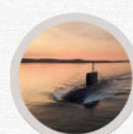

VOCATIONAL REHABILITATION VA BENEFITS: WHAT TYPES OF SERVICES CAN BE PROVIDED TO VETERANS? -ACTUALIZADO, MARCA, 27/03/2025

The VR&E program is authorized under Title 38, U.S. Code, Chapter 31 for veterans with service-connected disabilities, transitioning to civilian life and finding meaningful employment can be challenging.

The Veteran Readiness and Employment (VR&E) program, also known as Chapter 31, exists to assist these veterans by providing the necessary support to overcome barriers to employment.

How Chapter 31 helps veterans

Whether a veteran needs additional training, job placement assistance, or even help with independent living, VR&E offers a range of services tailored to individual needs.

Veterans who meet eligibility requirements, including having at least a 10% service-connected disability rating, can apply for a comprehensive evaluation to determine their rehabilitation needs and career goals.

Once accepted into the program, veterans work with a Vocational Rehabilitation Counselor (VRC) to develop a personalized plan.


The services available through VR&E cover multiple areas, including vocational counseling, which helps veterans assess their skills and interests, as well as employment services, such as job-seeking skills, resume development, and interview preparation.

Veterans who require additional education or specialized training can access On-the-Job Training (OJT), apprenticeships, or post-secondary education at vocational schools, technical institutes, or colleges.

For those who need extra support, the program provides case management, adjustment counseling, and medical or dental referrals through the Veterans Health Administration.

The basic eligibility period for these services is 12 years from either the veteran's separation from active duty or the date they received their service-connected disability rating.

For veterans considering VR&E, seeking guidance from a Veteran Service Officer (VSO) before applying can be beneficial.



Making the GRADE

Navigating and understanding service-connected education benefits can be extremely stressful when trying to determine how this aid interacts with regular financial assistance programs; what pays and what doesn't pay.

CHAPTER 33 VA BENEFITS: WHAT PERCENTAGE OF BENEFITS ARE YOU ENTITLED TO IF YOU SERVED AT LEAST 90 DAYS? *-LAPRESSE, MARCA, MAR 2025*

THE ELIGIBILITY TIER DETERMINES HOW MUCH YOU CAN RECEIVE FROM CHAPTER 33 BENEFITS BASED ON YOUR TIME IN SERVICE.

The Post-9/11 GI Bill®, also known as Chapter 33, is an invaluable help for veterans who want to continue or supplement their education. The benefit covers tuition and fees for the school or training program you choose; however, the amount you will receive depends on your time in service, among other factors.

To access Chapter 33 benefits, you must meet one of the following requirements:

- You have served on active duty for at least 1,095 days (36 months), or
- You have served on active duty and received the Purple Heart on or before September 11, 2001, or
- You have served on active duty for at least 30 consecutive days and you were discharged due to a service-related disability.

Don't worry, though. If you don't meet the requested time, you can receive a percentage of the total benefits based on your time of service.

How much can I receive for 90 days of service?

For all veterans who do not meet the 1,095 days (36 months) of service, the Department of Veterans Affairs (VA) implemented the "eligibility tier." Using this system, the department calculates the percentage to which you are entitled. If you served between 90 and 179 days (90 days to 5 months), you will receive 50% of the benefits.

Here is the rest of the eligibility tier:

- 910 to 1,094 days (30 to 35 months): 90% of the full benefit
- 730 to 909 days (24 to 29 months): 80% of the full benefit
- 545 to 729 days (18 to 23 months): 70% of the full benefit
- 180 to 544 days (6 to 17 months): 60% of the full benefit

What is the amount of Chapter 33 benefits?

The maximum amount you can receive under Chapter 33 in 2025 is \$28,937.90 annually if you are in a qualified higher education program. If you are receiving flight training, you will receive \$16,535.46 per year, and if you are in correspondence school, you will receive \$14,055.13 per year.

To calculate how much you will receive annually for 90 days of service, divide the above amounts in half. If you still have questions, contact or visit your nearest VA office in person.

CHANGES COMING IN JUNE FOR RETIREES WHO PAY SBP MONTHLY PREMIUMS DIRECTLY -DFAS.COM, APRIL 2025

Some retirees need to pay monthly Survivor Benefit Plan (SBP) or Reserve Component Survivor Benefit Plan (RCSBP) premiums directly instead of having them deducted from pay because their Department of Veterans Affairs (VA) disability compensation pay offsets their retired pay. We call that direct remittance. Most of these payments are handled by the U.S. Department of Treasury Centralized Receivables Service (CRS). When CRS receives the payment from the retiree, they report it to DFAS Retired and Annuitant (R&A) Pay to ensure the retiree's account is credited.

What You Need to Know

In June of this year, R&A Pay will begin issuing all monthly direct remittance SBP premium billing statements and collecting all SBP premium direct remittance payments instead of using Treasury's CRS.

This means retirees will need to either: (1) make their payments to a different mailing address or (2) change their electronic payments if they have them set up to pay to CRS or (3) use Pay.gov to pay DFAS.

This month, DFAS mailed a letter explaining the changes to all retirees who will be affected. The letter will be followed by an emailed SmartDoc to the retirees who have a valid email address in myPay. Changes like this are one of the reasons it's important for retirees to keep their mailing address and email address updated with DFAS.

What You Need to Do

It's important that DFAS has your current mailing address so you receive the billing statement with new payment instructions. If your address has changed, DFAS has several convenient options for updating the mailing address on your retired pay account.

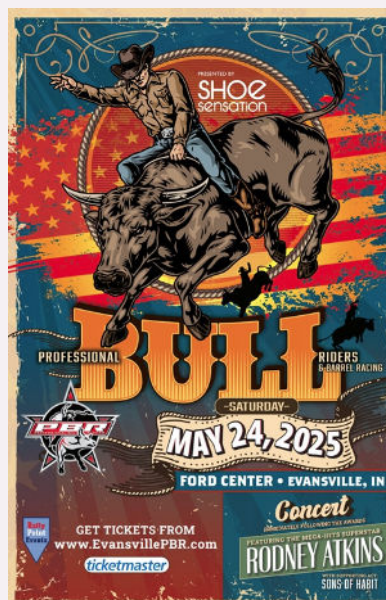
1. Use our askDFAS online tool to update your address: find out more on our Quick Tools webpage at <https://www.dfas.mil/raqicktools>
2. Send a completed and signed DD Form 2866 to request we update your mailing address.
3. Change your address using myPay: <https://mypay.dfas.mil>
4. Call our Customer Care Center during normal business hours to update your address: 800-321-1080

You can make the change to one of the new payment options below to pay DFAS directly right now. You don't have to wait for June. Automatic Payments

If you have an electronic/automatic payment set up with your bank, ensure that you make the change early enough to send your June payment to DFAS instead of CRS.

MILITARY RETIRED PAY TAX SEASON TIPS:

The April 15, 2025 tax deadline is arriving soon and now is a good time to make sure you have all your tax documents ready. Here is a summary of retired pay tax season tips and the DFAS tools available if you are missing documents. For those who may not know, the 1099-R is the retiree tax statement, like the W-2 provided to wage earners. The 1099-R document shows the amount of taxable retired income earned and how much was withheld in taxes – and must be filed with your tax return. Retiree 1099-Rs are available in myPay. The best way to obtain your 1099-R is to use myPay, <https://mypay.dfas.mil>. With a myPay account, you can find the most important retired pay information, including your 1099-R. The advantage of using myPay is you have 24/7 access to your tax documents. You can print or download the current year tax statement and access previous 1099-Rs in myPay (up to four prior years for retirees) to compare, or if you need to file an amended return.

Requesting a Duplicate 1099-R

If you are not using myPay yet, we do offer other convenient options to request a replacement IRS Form 1099-R. As of February 10, 2025, you can get your 1099-Rs sent to the address on file with DFAS or to a one-time, temporary mailing address by submitting a request online. Our online request tool also accepts international addresses. It's easy to find on our Quick Tools webpage: <https://www.dfas.mil/raquicktools>

DFAS also provides a self-service telephone option for retirees. Retirees can access the phone option at 1-800-321-1080. If you are a retiree using the phone option, please verify your current mailing address is correct. The telephone option is currently available for retirees and only for the current year tax statement.

The 1099-R should be in the mail within 7-10 business days to the address we have on record.
